

Nintendo DS Raffle

The winner of the drawing wins a Nintendo DS.

Official Rules

1. **ELIGIBILITY:** The Drawing is open only to those 18 years of age and older. Employees of AAA Mid-Atlantic Inc., and their immediate families are not eligible to win. **No purchase is necessary to enter.**
2. **HOW TO ENTER:** The Drawing will be held on Saturday, January 14, 2012. To enter, complete and deposit the Drawing Entry form available on the day of the drawing at the AAA Mid-Atlantic Inc & Radio Disney booth at the Philadelphia Inquirer Travel Show, between the hours of 1:00pm – 3:00pm on January 14, 2012. Limit one entry per household. Multiple entries will be disqualified.
3. **HOW TO WIN:** The drawing will be held at 3:00pm on January 14, 2012 at the AAA Mid-Atlantic booth. **Prize winner must be present to win.** Winner will be announced at the AAA Mid-Atlantic Inc. & Radio Disney booths. Winner must identify him/herself within two minutes of the announcement of the winner. If the prize is not claimed within the time limit, an alternate prizewinner will be drawn at random from all eligible entries. The prizewinner will be required to execute and return, prior and as a condition to receiving the prize, an affidavit of eligibility and, except where prohibited by law, a publicity release.
